  4. Take MO-100 E. exit, Exit # 253, toward Gray Summit/I-44 Bus Loop (0.16 Mi)
  5. Keep right to take the ramp toward Gray Summit/Manchester/Purina Farms (0.03 Mi)
  6. Turn Right onto Highway 100/MO-100 (0.42 mi)
  7. Turn left onto Highway MM/MO-MM  
Highway MM is 0.2 mi past Pettus Ave. (1.16 Mi)
  8. Turn left onto Checkerboard Dr. (Gate access required) Checkerboard Dr, is just past Danforth Dr.
